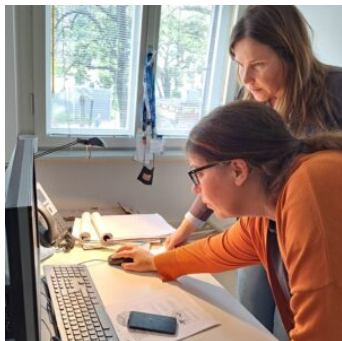


In March and April 2025, **FBK-IRVAPP experts delivered lectures to executives, civil servants, consultants, project managers, and researchers** on various methods, both experimental and qualitative, for evaluating public policy. The sessions specifically focused on the skills required to understand and effectively use the results of impact evaluations.

The 300 available spots were sold out early during the enrollment period, and student reviews were overwhelmingly positive, as indicated by the satisfaction surveys. In fact, **95.4% of students reported being satisfied.**
